It gives me great honour to welcome you to our National Institute for Occupational Health COVID-19 Centenary Webinar.

The NIOH is one of the divisions of the National Health Laboratory Service (NHLS) that plays a significant role in the provision of occupational health and safety services to workplaces - both in the formal and informal sectors of the economy. The NIOH works together with other subsidiaries of the NHLS including the National Institute for Communicable Diseases (NICD) which includes National Cancer Registry, and the newly integrated Forensic Chemistry Laboratories.

During the initial phase of the pandemic, testing for SARS-CoV-2 was done by the NICD thereafter, working together, the NHLS rapidly decentralised testing to its laboratories as COVID-19 case numbers started to increase.

The NHLS continues to play a pivotal role in providing testing for COVID-19 in the public sector and has been instrumental in researching about the SARS-CoV- 2 virus while also providing advisory services to the National Department of Health and other stakeholders.

The pandemic, as we have witnessed, impacted workplaces across the globe and the NHLS certainly was no different. The NIOH provided substantial advice and guidance to the NHLS Board and Executive Management in drafting mitigating strategies and updating Health and Safety policies. The Institute took the lead in creating awareness and advising workplaces, both in the public and private sector, in assuaging and preventing the spread of the pandemic.

In collaboration with academia and experts from numerous National Government Departments, the NIOH contributed to COVID-19 regulations, directions and guidelines related to workers and workplaces. Webinars and other training events were used to equip the industry with the tools required to protect and promote workers' health and safety, including the safe return to work during the pandemic.

Today, I am pleased therefore to celebrate with you this milestone – the 100<sup>th</sup> training webinar - with over 53 481 participants being trained on COVID-19-related topics to date.

Our collective action, responsiveness and relevance as an organisation has demonstrated how we could contribute to the national agenda in a time of a pandemic.

I hope this day of reflection allows us to foster existing partnerships and establish new ones as we continue to build upon the foundations of unity and cooperation that have already been laid. I wish to acknowledge and thank the NIOH staff and the NHLS community for their steadfast commitment and dedication as well as the many stakeholders and partners here with us today that have provided support to the NIOH in its outbreak response.
