- In place since early April 2020
- Part of the Incident Management Team (IMT) national Covid-19 response
- Inputs to NEDLAC, JSOC, NDOH / Tech NHC and NHC; work with NICD, MRC, WHO, ILO; AUDA-NEPAD
- OHS Committee unions, private & public sectors, professional societies
- OHS Technical (academic OH depts, NIOH)
- Dealt with workplace interventions & vaccination programme for workers; multilateral agencies

#### **Covid-19 Vaccinations**



- Rollout of vaccinations in workplaces
- Development of a database of workers in formal sector
- Targeted vaccinations by age bands, numbers of workers and sectors initially
- Health workers (J&J)
- Other workers (Pfizer)
- Mining and large manufacturing ~70% vaccinated
- Training, sensitisation and communication in workplaces
- Engagement via NEDLAC for workplace vaccinations




#### Assessing Covid -19 positive worker

#### Decontamination of work-place




- Clean workplace where worker spent most time
- IPC guidelines (bleach solution)
- No need to deep clean or implement any other form of cleaning in areas that were unoccupied for more than 7 days
- Time to return to work depends on chemicals used for decontamination / cleaning – seek advice from service provider
- Do not do fogging

#### Surveillance System / Reporting



- Governance (OHS Workstream)
- Surveillance and reporting to National Institute for Occupational Health (NIOH)
   agency of the NDOH
- Data required
  - Risk assessments
  - Vulnerable employees (age, co-morbidities)(anonymized)
  - Symptom screening (anonymized)
  - Testing (identified)
  - Positive workers (identified recovered, dead, hospitalized)
  - Contact tracing (anonymized)
  - Cluster outbreaks (special investigation)
  - Reported to DEL Chief Inspector / Compensation Commissioner
- Reports (anonymized) company, sector, geographic area, occupation, demographic information)





#### HCW Infections (4 August 2020)



- By 4 Aug, 27 360 HCWs were infected (public 21 333 (78%) & private sector 6027 (22%))
- 16 005 recovered (58%)
- 5% of all infections (global 10%)
- Mortality 0.9% (240; 203 public & 37 private)
- Between 4 July and 31 July 2020 → 18,841 new HCW infections
